The intercontinental business between Europe and other continents is growing steadily every year. In fact the intercontinental traffic in 2014 increased by 5,2% in Asia-Europe, 5,5% in Africa-Europe and 4,8% and in America-Europe routes, and the projections for the coming years are that sustained growths of maritime trade flows would persist, be it with stronger concentration around Asia.

This trends causes significant impacts on: the balance of trade and GDP growth in the EU; infrastructure, carriages and transport modalities; logistics costs and procedures; manufacturing activities; passenger and freight flows in the Trans-European Core Transport Networks and last but not least on the environment.

In this context, it is very important to identify the drivers of change, challenges and opportunities for the European economy and transport networks which relate to changes in trade balances.

Both the interconnection with neighbouring countries, particularly in the cases of Eastern Europe and Mediterranean basin, as well as the promotion of new intercontinental routes, are additional key issues. It is expected for instance that freight volumes over the Eurasian land bridge will increase with 80% by 2050.

Obviously, the economic activity is concentrated in the main cities and smart inter-cities links, including the efficiency of the major "gates" (ports, airports, railway stations and inter-modal terminals, where flows are canalized) are a vital requirement in this global world.
